PORT MADISON YACHT CLUB JUNIOR SAILING PROGRAM CODE OF CONDUCT

It is the responsibility of parents/guardians, sailors, and junior instructors to read, understand, and abide by all of the rules and conditions of the Code of Conduct.

General Safety

- Whistles are to be used in case of emergency ONLY.
- No glass containers are allowed anywhere on yacht club grounds or in the boats.
- No running on the docks, pushing into the bay or unauthorized swimming.
- No one shall swim under docks.
- No climbing or playing on or around boat hoists or on garden or wood shed.
- No one shall jeopardize the safety of others, or themselves.
- No one shall board private boats without prior permission.

Behavior

- As in our schools, there will be a zero tolerance policy regarding any instructor or student possessing and/or using any harmful weapon, alcohol, controlled substance, or any tobacco products. No possession or use of any substance containing alcohol, tobacco, or any controlled substance, except medicine prescribed by a physician specifically for the individual's use. (Said use and need MUST be specified in their registration form.)
- Sportsmanlike conduct is expected from instructors & students at ALL times, both on and off the water. Foul language, harassment, intimidation, bullying, and any disrespectful behavior will not be tolerated. Repeat offenses qualify as grounds for removal from the program.
- Borrowing anything without prior permission from the owner is stealing, and therefore prohibited.
- No littering, anywhere. Make a mess, clean it up! See a mess, help clean it up!
- Any instructor or student unwilling to participate in the program activities will be sent home. Neither the instructors nor PMYC can be responsible for instructors or students who are not participating in the available sailing program activities.
- Each instructor & student is responsible for his/her own belongings. All personal belongings should be labeled with your name (life jackets, gym bags, jackets, etc). PMYC is not responsible for loss or damage to personal property or equipment. • Instructors & students will return boats and equipment to proper storage areas as soon as possible upon completion of the class. Boatyard and launch areas will be kept clear of obstructions.
- Instructors & students are required to remain at the club during scheduled program hours.
- Instructors & sailors are not allowed to swim after class without parental supervision. Instructors are NOT responsible for sailors after class.

Attire

- US Coast Guard approved life jackets (PFD), with whistles tied on, must be worn and properly fastened at all times while on the water and at other times as directed. Anytime the instructor, students, and parents are on or near the water, docks and ramps, their lifejacket must be on and fastened.
- Come prepared to sail in any weather conditions. (Rain or shine, cold or hot.)
- Shoes, booties, or sneakers are to be worn at ALL times. No open toed shoes. No bare feet on docks.

Attendance

- Instructors & sailors are expected to show up on time for all classes, rain or shine.
- If an instructor or sailor is unable to attend, or will be late, the Coordinator MUST be notified. Call or text Frank Renna at 206-724-6074, call the clubhouse phone at 206-842-8826, or email sailingschool@portmadisonyc.org.

Discipline

Generally we have had very few problems with children running afoul of the Code of Conduct, and we hope your children will abide by these common-sense rules. But when infractions occur, it is unfair to all the kids if those infractions are not dealt with. Inappropriate behavior will not be tolerated. Behavior that is disrupting the learning environment or threatening the safety of others is considered inappropriate. If the Code of Conduct is violated or if inappropriate behavior continues after the child has been warned, the instructor will remove the student from the situation and refer the offender to the Coordinator who will determine the necessary action. If necessary, the Coordinator may contact the child's parent for immediate pick up. Upon infraction of the Code of Conduct, the student may be warned, suspended, or dismissed from the program, depending on the discretion of the Coordinator. Class fees will not be refunded in these situations.

It is the responsibility of parents/guardians, sailors, and junior instructors to read, understand, and abide by all of the rules and conditions of the Code of Conduct.
